FRENCH IMPORT RESTRICTIONS

Request by Uruguay for Consultations under Article XXII

In accordance with the procedure adopted by the CONTRACTING PARTIES on 10 November 1958 (BISD, Seventh Supplement), the Government of Uruguay has informed the Executive Secretary that a request has been addressed to the Government of France to engage in consultations under paragraph 1 of Article XXII concerning products, the importation of which into France from Uruguay is subject to quantitative or other restrictions or to discriminatory treatment.

The products which will be the subject of the consultation are those which normally comprise Uruguayan exports to world markets (see list below), other than those whose importation into France has been liberalized under the Notices to importers published in the Journal Officiel of 5 January and 9 April 1961.

The Government of Uruguay has suggested that this consultation should take place either towards the end of June or towards the end of August or the first days of September and in any case before the next meeting of the Council scheduled for 25 September. Any contracting party wishing to assert a substantial trade interest and desiring to be joined in the consultation should so inform the Governments of Uruguay and France and also the Executive Secretary without delay in accordance with the procedures referred to above.
