AUSTRIAN IMPORT RESTRICTIONS

Request by the United States for  
Consultations under Article XXII

In accordance with the procedures adopted by the CONTRACTING PARTIES on 10 November 1958 (BISD, 7th Supplement, page 24), the Government of the United States has informed the Executive Secretary that a request has been addressed to the Government of Austria to engage in consultations under paragraph 1 of Article XXII concerning the maintenance by Austria of quantitative restrictions on the products listed below.

<u>Austrian Tariff No.</u>	<u>Commodity Description</u>
11.02	Cereal groats and cereal meal, other worked cereal grains (rolled or flakes, etc., except husked, glazed, and broken rice), edible germs of cereals
11.08	Starches and starch flour, Inulin
11.09	Gluten (roasted or not) and gluten flour
ex 15.02	Raw and rendered tallow of cattle, sheep and goats <u>other</u> than technical tallow such as prime tallow, fancy tallow and yellow grease
15.03	Lard stearine, oleo-stearine, lard oil, oleomargarine not emulsified or mixed or prepared in any way
ex 15.07 C 2	Purified soybean and cottonseed oil, peanut oil, coconut oil, palm oil, palm kernel oil
ex 15.13	Margarine, mixtures of edible fats (artificial edible fat) and other prepared edible fats <u>other than</u> : mixtures of hardened oils

ex 20.02 B	Peas and beans preserved otherwise than by vinegar or acetic acid, in <u>other than</u> air-tight containers of 15 kilograms of gross weight or less
ex 20.07 A	Thick juices of apples, pears and grapes whether or not containing sugar, but unfermented and not containing alcohol
ex 20.07 B	Juices of apples, pears and grapes whether or not containing sugar, but unfermented and not containing alcohol
22.05	Wine of fresh grapes, including grape must with added alcohol
22.06	Vermouths and other wines flavoured with aromatic essences
24.01	Unmanufactured tobacco; tobacco refuse
24.02	Manufactured tobacco; tobacco extracts and essences.
